### PRODUCT NAME(S):

Salts **FreshAire** Odour Eliminating Spray

### 2. INTENDED USES:

To remove excess flatus odour from surrounding area, by chemically neutralising, not masking, odours.

### 3. COMPOSITION:

'Bag in Can' (no flammable propellant) aerosol containing an aqueous solution of Quaternary polyphenolic compounds derived from grapeseed extracts, Citric Acid, Ascorbic acid, Niacin, Thiamine hydrochloride, Glycerol.

### 4. PHYSICAL AND CHEMICAL PROPERTIES:

Water based solution, incompatible with high pH materials.

Toxicological and Environmental effects:- None hazardous to environment. Readily biodegradable.

### 5. HEALTH HAZARD:

No health hazard is anticipated during normal handling of this product. Avoid contact with eyes - may cause irritation. Stop using product if sensitisation occurs.
