The cardboard items are manufactured of cardboard, depending on the designs they are decorated with ink and varnish.



With reference to documentation from our suppliers, we declare that all used materials meaning:

- Cardboard; Tamfold or Tambrite from StoraEnso.
- Printing inks; Novasens® 660 Premium
- Varnish; G9/378 TerraWet Gloss Coating

Are in compliance with:

REGULATION (EC) No 1935/2004 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 27 October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC.

The board is intended for packaging dry, moist, non fatty and fatty foodstuffs.

The board is suitable for use under the following conditions of temperature and time

- Freezer / fridge (-20°C to 5°C more than 24 h)
- Room temperature (up to 40°C for more than 24 h)

The items **can not** be use in the microwave oven or in a conventional oven.

The items are produced in compliance with Regulation (EC) No 2023/2006 on good manufacturing practice for materials and articles intended to come into contact with food. And are fulfilling Danish Executive Order number 822 of 26/6-2013 for food contact materials

The sum of lead, cadmium, mercury and hexavalent chromium in the cardboard is less than 100 ppm (EN 13428)

No Phthalates or Bisphenol A are intentionally added in the production of cardboard items.

Mineral oils, saturated hydrocarbons (MOSH) and aromatic hydrocarbons (MOAH) are not intentionally added. Neither to the raw materials used, nor in the production at Schur Pack Denmark a / s. We are aware that both MOSH and MOAH can be present, even in virgin fibers used to produce cardboard. We are therefore in an ongoing dialogue with our suppliers, to ensure that we only use cardboard with the absolute lowest content of MOSH and MOAH.

The cardboard packaging complies with the Packaging and Packaging Waste directive 94/62/EC amended by 2004/12/EC and can be disposed in accordance with:

- DS / EN 13430:2001 Packaging Requirements for packaging that can be recoverable in the form of material recycling.
- DS / EN 13431:2001 Packaging Requirements for packaging that can be recoverable in the form of energy recovery.

Before use the items are optimally stored at 20°C and 50 - 55 % RH The storage time for items, before filling should not exceed 12 months.
