When packing moist and fatty foodstuffs we recommend a functional barrier between the food and the board for technical reasons although a direct contact is allowed.

We hereby declare that Mineral Oils Saturated Hydrocarbons and Aromatic Hydrocarbons are not intentionally added in the manufacturing of the raw materials, nor in the production at Schur Pack Denmark a/s.

We are aware that both MOSH and MOAH can be present in virgin fibers used to produce paperboard.

¹ It is the responsibility of the packer of the finished articles to ensure that the article is safe to use in the intended conditions. "Hot-fill" means the filling of any article with a food with a temperature not exceeding 100 °C at the moment of filling, after which the food cools down to 50 °C or below within 60 minutes, or to 30 °C or below within 150 minutes.
