Others

- Substances referred to in the Chemical Act and being part of the list of banned substances, i.e. heavy metals and azo-dyes, have been entered in the German Regulations for packaging. The limiting values of the materials used in our production fall below the therein indicated maximum permissible values.
- We inform, that the from us used materials, referring to our suppliers formulation don't contain
 - Dimethyl Fumarate (DMF) respectively radioactive steel
 - **■** Cobalt Dichlorid
 - Latex
- Our masking tapes and backing papers are with a percentage of 0,5 12% depending the weight of unit area with silicon coated, this is no hazardous substance pursuant to the hazardous substance regulation and according the EG-Guidelines.
- Drying Bags are not used in our packaging!

Our declaration is based on the data of our previous suppliers. Although the substances which subject to limitations in above mentioned regulations are not used or added on purpose, the presence of negligible hints caused by e.g. contamination can't be excluded fully. As the appearance of those substances is seen as very unlikely, we abandon a chemical investigation to prove their absence due to economical reasons.
