The items are paperboard packaging without any kind of decoration neither at the outside nor at the inside. For this type of item there is only used materials which is suited for the intended use of the items.

## **Specification of the product**

The items are manufactured using the following material:

**Paperboard:      CKB Nude™230 g/m<sup>2</sup>**

## **Intended Use**

Based on documentation from our supplier the items may safely be used for food packaging, and may stand in direct contact with dry, moist, low alcoholic and fatty foodstuffs.

The packaging is intended for use under the following conditions of temperature and time:

- Freezer/fridge
- Room temperature (up to 40°C for more than 24 hrs.)
- Hot-fill<sup>1</sup>

The packaging is not intended for use under the following conditions and temperatures

- De-freezing and/or re-heating of food (e.g. ready meals) in microwave oven
- Conventional oven

<sup>1</sup> It is the responsibility of the packer of the finished articles to ensure that the article is safe to use in the intended conditions. "Hot-fill" means the filling of any article with a food with a temperature not exceeding 100 °C at the moment of filling, after which the food cools down to 50 °C or below within 60 minutes, or to 30 °C or below within 150 minutes.

## Compliance with European food contact legislations

### **Bisphenol A (BPA)**

We hereby declare that Bisphenol A are not intentionally added in the manufacturing of the raw materials, nor in the production at Schur Pack Denmark a/s.

### **Phtalates**

We hereby declare that Phtalates are not intentionally added in the manufacturing of the raw materials, nor in the production at Schur Pack Denmark a/s.

### **Titanium dioxide ( TiO<sub>2</sub> )**

We hereby declare that Phtalates are not intentionally added in the manufacturing of the raw materials, nor in the production at Schur Pack Denmark a/s.
